**Proposal: T6-Oak**: Remove dead wood and crown thin by 10%. Reduce 2x lowest branches and 1x upper branch growing towards the house by 2 metres to leave a finished radial spread of 9 metres. Crown lift to 5 metres.

**T4-Oak:** Remove dead wood and crown thin by 10%. Remove lowest ½ dead branch growing towards the house. Reduce 2 long low branches growing towards the house by 2 metres to leave branch length of 9 metres. Reduce long lowest branch growing towards rear boundary by 2 metres to leave finished branch length of 8 metres.
