Purpose of Today's Drop-In Event



- 1) Raise awareness of Hampshire Highway's proposals for traffic calming in Frith End & Blacknest; and gather parishioners' feedback on these traffic calming proposals.
- 2) Raise awareness of other actions being undertaken by Binsted Parish Council's Transport Working Group to improve local road safety
- 3) Identify additional volunteers to assist our existing Transport Working Group and Community Speed Watch teams

Traffic Calming is one of 6 actions being progressed to improve Frith End & Blacknest road safety

1) Traffic-calming project (as promised in 2012)

2) Repairs to damaged road elements

 Dire condition of Blacknest & Frith End road surfaces, verges and missing signs needs fixing.

3) Further safety projects

• A325 junctions & speed limits need review

4) Enforcing speed and HGV rules

- Speeding traffic is a major concern.
- Signage and enforcement of HGV rules also a concern.

5) Creating an off-road cycle route

- Sustainable travel option needed from Bordon to Bentley Station.
- Road is too narrow for on-highway cycle routes.

6) Scrutising planning applications' traffic impacts

- Steep increases in traffic volumes & HGV sizes already cause concern on narrow rural roads. (Bordon expansion still only at midway point.)
- NPPF is problematic as planning applications can only be opposed on transport grounds if transport network impacts are 'significant'.

Progress made so far:

1) Traffic-calming project (as promised in 2012)

- s106 funds from Whitehill-Bordon expansion are now secured.
- November 2024: Highways signed project initiation agreement.
- Jan 2025: Traffic calming concept plans received from Highways.

2) Repairs to damaged road elements

- BPC & residents actively use 'Report a Road Problem' system to lobby for urgent, proper resurfacing of Blacknest & Frith End roads. Highways has made recent site visits.
- BPC is additionally lobbying for remediation of carriageway edges and verges resulting from B3004 SSEN diversions.

3) Further safety projects

- 40 issues causing road safety concern have been documented.
- A325 junctions: BPC has asked Highways to clarify future plans.
- BPC is working with Binsted & Rowledge schools on road safety.
- BPC is working with British Horse Society to identify best locations for horse rider signage on Blacknest Road.

4) Enforcing speed and HGV rules

- We have put in place all possible volunteer-led speed projects (Community Speed Watch; Speed Indicator Devices; Cameras.)
- We have Highways' commitment to improve A325 HGV signage and to design signage to deter HGVs from Jolly into Frith End.

5) Creating off-road cycle route

 BPC has responded to several LCWIP and Sustainable Travel consultations, using data obtained in BPC's 2019 Cycling Survey.

6) Planning applications' traffic impacts

- BPC is scrutinising large planning applications & Local Plans.
- We include accurate traffic data, collected from relevant SIDs.

Action still needed:

1) Traffic-calming project (as promised in 2012)

- BPC will give your feedback on Highways' traffic calming concepts.
- A detailed design and Road Safety Audit will be the next steps.
- Further site work will then be required for detailed design.
- "Highways is aiming to progress the scheme to the implementation stage within 2025-26 financial year."

2) Repairs to damaged road elements

- The proper remediation of road surfaces and verges and the replacement of missing road safety signs remain vexed issues!
- Highways is discussing deploying its Dragon Patcher in Blacknest in this financial year.

3) Further safety projects

- Highways will repair Binsted School flashing lights
- Need to identify solutions for road safety issues at Binsted and Rowledge schools
- BPC is maintaining its list of road safety concerns in the parish.

4) Enforcing speed and HGV rules

- Transport WG volunteers will install new Speed Indicator Devices.
- Volunteers are needed to help verify Speed Camera data.
- Volunteers needed to set up Rowledge Community Speed Watch.
- Hampshire Police has promised help to enforce speed &HGV rules.
- Highways has promised to deliver the promised HGV signage.

5) Creating off-road cycle route

• Sustainable travel option needed from Bordon to Bentley Station.

6) Planning applications' traffic impacts

- EHDC and SDNP Local Plan Reviews will need our continued focus.
- We also need to understand how HCC's 'Project 2050' (to make transport more sustainable) will affect future decisions.

Timeline: Traffic calming discussions for Frith End to Bentley route

2012: Frith End to Bentley route was one of 9 local routes promised traffic calming measures by Bordon & Whitehill's regeneration project. Funding for this was written into the Bordon developments' s106 agreements.

By 2022: Traffic calming on all routes except ours had been implemented. **March 2022:** BPC starts to collect traffic volumes and speeds from its SID. **Summer 2022:** Residents participate in a 'Rapid Evidence Review' and document 40 safety improvements needed on Frith End and Blacknest road stretches (excluding the junctions.) The review confirms support for a

Nov 2022: BPC secure site visit from Highways to cost traffic calming plan.

30mph speed limit and physical traffic calming buildouts.

Spring 2023: Hampshire Highways become convinced that Frith End is *not* covered by Bordon s106 agreements.

Spring 2023: As potential alternative to s106 funding, BPC help Highways to write Strategic CIL 'public realm' funding bids to SDNP and EHDC for 2 small traffic calming elements. Both bids fail¹.

Summer 2023: Road safety and traffic volumes are confirmed as Binsted parish residents' top priorities in the parish-wide survey undertaken by BPC to develop Binsted's Parish Priority Statement.

October 2023: BPC tracks down the document proving that Frith End *is* covered by Bordon s106 funding!

November 2023: Communications with Hampshire Highways evaporate after a key staff member leaves and his successor is unresponsive.

March 2024 - After intense lobbying, BPC secures a meeting with Highways s106 portfolio manager and discuss 40 safety improvements sought.

May 2024: BPC supply data about traffic flows to Highways' s106 team.

July 2024: After further lobbying, BPC meets new Engineering Manager.

October 2024: Ring-fenced s106 funding for Frith End project is approved.

November 2024: Highways' project initiation agreement is signed.

31 January 2025: BPC receives Concept Plans for Traffic Calming scheme.

¹ EHDC's Strategic CIL 'Growth' criterion specifically excludes traffic calming!
